VOTING DATES AND LOCATIONS

ADVANCE VOTING will be available to qualified electors at the Village of Zeballos Municipal Office on **Wednesday, October 10, 2018** between the hours of 8:00 am and 8:00 pm and **Monday-Friday, October 15-19, 2018**, between the hours of 8:30 am and 4:30 pm.

MAIL BALLOT VOTING will be open to qualified electors. Complete and return an application for Mail Ballot by October 1, 2018.

GENERAL VOTING DAY will be open to qualified electors of the Trustee Electoral Area 3 - Zeballos School Attendance Area of Electoral Area ‘A’ (Strathcona Regional District) on Saturday, October 20, 2018 between the hours of 8:00 am and 8:00 pm in the Village of Zeballos Municipal Office.

ELECTOR REGISTRATION

There is no need to pre-register to vote as the registration of all electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older on general voting day
- Canadian citizen
- resident of BC for at least six (6) months immediately preceding the day of registration
- resident of OR registered owner of real property in the Zeballos School Attendance Area of Electoral Area ‘A’ (Strathcona Regional District) for at least 30 days immediately preceding the day of registration, and
- not disqualified by the *Local Government Act* or any other enactment from voting in an election or otherwise disqualified by law.

To register, resident electors must produce **two (2) pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

To register, non-resident property electors must produce **two (2) pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from the other property owners.
